RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAWTHORNE, CALIFORNIA DIRECTING THE CITY MANAGER TO: 1) CANCEL THE TRADITIONAL STATE OF THE CITY LUNCHEON EVENT TENTATIVELY SCHEDULED FOR WINTER 2021 DUE TO THE COVID-19 PANDEMIC & THE GOVERNOR'S ORDER PROHIBITING LARGE GATHERINGS; 2) INSTEAD SCHEDULE A PRE-RECORDED VIDEO PRESENTATION BY THE MAYOR OF THE STATE OF THE CITY ON HAWTHORNE COMMUNITY TELEVISION AND SOCIAL MEDIA; 3) NOTIFY THE CHAMBER OF COMMERCE IMMEDIATELY THAT THE CITY WILL SOLELY ASSUME RESPONSIBILITY FOR THE STATE OF THE CITY EVENT ON A GOING FORWARD BASIS AND THAT THE CHAMBER OF COMMERCE IS DIRECTED NOT TO COLLECT ANY FUNDS FROM CITY BUSINESSES FOR THE STATE OF THE CITY LUNCHEON; AND 4) NOTIFY ALL PRIOR SPONSORS AND DONORS OF THE EVENT THAT THE CHAMBER OF COMMERCE WILL NO LONGER BE HANDLING THE EVENT.
