City Clerk **Huber**, announced the new Common Space Brewery in town. the Pancake Breakfast at the Historical Society. State of the City, the Bunny Breakfast, the Parks and Recreation Foundation Golf Tournament,

Councilmember **Michelin** thanked everyone who came to honor Jerry Nibel, congratulated the new commissioners, recommended to put all the events happening in the city on the website, attended the North Hawthorne Homeowners meeting and received several complaints on parking, garage conversions and not answering phone calls in City hall.

Councilmember Valentine attended the Common Space Brewery in Hawthorne, the stack event for the Marriot Hotel, the Holly Park Little League opening ceremony. Thanked everyone who attended the signing ceremony and requested that the letter from Coronel Roberts, the appropriates form and the contact number for the person on the veteran's commission in charge of this be put on the website to invite landlords to participate on this event.

Councilmember Reyes English thanked the Veteran's commission for all their work which assures that veterans have representation in the city, attended the League of Cities dinner, the modular stacking event, and reminded residents of the Service Provider Fair on April 21<sup>st</sup>, 2018. She thanked the city council for approving Ordinance No. 2156 which authorized the implementation of a Community Choice Aggregation Program, which is now comprised of 31 cities and stated that she has been participating in the board meetings as an elected official for the City of Hawthorne. They recently voted to rename the board – the Clean Power Alliance of Southern California. She was appointed the chair of the community advisory development committee and community members will have an opportunity to participate in various committees. There will also be job opportunities for this new "utility company" which will be in competition with Southern California Edison.

Councilmember **Awad** thanked the Veterans Commission for all the work they do providing help for the veterans, condolences to Mrs. Nibel, thanked staff and the Directors for the work done taking Hawthorne to a different level, residents comments on changes and new businesses, thanked Chief Fager for bringing crime rate down in the City, he also thanked City Manager Arnie Shadbehr for his great leadership.

Mayor **Vargas** attended along with the rest of the city council the stacking ceremony for the Marriot Hotel, and the new Common Space Brewery in Hawthorne, asked that the City improve on customer service, requested more information on the Clean Power Alliance, Received compliments on the beautification and the new openings of businesses in the City.
