Director's Report:

- A. 2017-18 Budget The 2017-18 Budget was passed at the May 9th City Council meeting.
- B. Bicentennial Park Project The Park is 96% complete. There was a slight problem with size of rocks placed in the park. The rocks were too small and could potentially be a hazard. Rocks will need to be removed.

Commissioner's Discussion Action/Items:

A. Proposed Mural Donation for Ramona Park - Velvet Marshall is interested in donated a mural to the City of Hawthorne. Velvet is passionate about painting. Velvet teaches painting classes for kids. She researched the City of Hawthorne and that is what motivated her to paint this mural. If possible, Velvet would also like to get the local High School kids to come out and help with the mural.

Jason Gromski – 4598 W. 132^{nd} St. Hawthorne. This would be a great enhancement to the park. Which side will the mural be painted on? Will the colors clash with the brown color on the building? What is the lifespan of the material used?

Velvet's response was she could paint the mural on either side of the building it would be up to the commission. The colors that were chosen will not clash with the color of the building. The mural will be sealed once it is completed and that would prevent the colors from fading and protect against graffiti.

William Myers -4744 W. 132^{nd} St. Apt# 17 Hawthorne. Mr. Myers prefer the mural be painted on the inside to the park. It will be more visible to the kids playing in the park.

Commissioner Balboa asked if you have a financial commitment. Velvet is looking at the cost being \$400.00 for paint and materials. Commissioner Balboa also asked Commissioner Plascencia if she talked to any of the local groups to see about raising funds for this project and other projects in the future. Commissioner Plascencia has not yet but plans to do so. Commissioner Balboa also recommended taking a copy of the drawing to their HOA meeting. It's important to make sure everyone see's the painting that will be going on the building.

Commissioner Plascencia has an artist that would like to donate panels to the City. They are beautiful and each panel has a meaning.

Commissioner Yates announced that he is looking to move out of the area in the next 2 months or so.
