H. NEW PUBLIC HEARINGS

1. Zone Text Amendment 2017ZA08

Brian James, Director of Planning and Community Development, presented a recommendation to the City Council regarding a proposed ordinance amending the Hawthorne Municipal Code to add parameters and standards to Chapter 17.22, Specific Plans.

Chairperson Ortiz expressed the desire not to limit maximum density and to maintain the flexibility to allow each project to be judged through the specific plan process, which provides ample opportunity for scrutiny and review. The other Planning Commissioners expressed concurrence with the proposed ordinance, especially given that it could be amended for deserving projects through the same processes as the adoption of the specific plan.

Gary Premeaux, owner of Ocean Gate Properties Inc, told the Commission about the Primavera Specific Plan and other projects he has been involved with that were of a high quality and a greater density than 30 units per acre.
