The Planning Commission would still be the determining body for land uses issues generally.

Director McClain stated that this commission is set up separately because variances are tightly controlled under state law so an Airport Hazard Variance is a bit different and it has to be handled by a different body.

Commissioner Mike Talleda asked if the Zone Text Amendment 2016ZA02 made it to the council for discussion. Planning Director Gregg McClain stated that it will be at the following meeting for introduction.
