As a native of Hawthorne and a proud City of Hawthorne retiree, and even prouder member of the Hawthorne LAX Lennox Rotary Club as well as a Life Member of Hawthorne VFW Post 2075, I am asking that the Hawthorne City Council to not eliminate the sale of safe & sane fireworks in Hawthorne. And I totally support any effort to eliminate the sale and discharge of illegal fireworks in our city.

Up until the recall of three city council members in 1983, only the member organizations of the Hawthorne Veterans Council were permitted to sell safe & sane fireworks. The groups included World War I Veterans and Ladies Auxiliary, Hawthorne Veterans of Foreign Wars Post 2075 & Ladies Auxiliary, and Hawthorne American Legion Post & Ladies Auxiliary. The trade off was the Veterans Council conducted a free fireworks show for the community at Hawthorne High School.

One of the campaign promises of the three individuals who were elected as a slate to fill the vacant seats after the recall was that the city council would open up the fireworks sale to all eligible Hawthorne-based nonprofit 501(c)(3) organizations. A limit of 10 stands was established and a lottery style selection process was implemented due to the fact that a large number of organizations intended to apply.

Since then literally hundreds of thousands of dollars have been raised which is turned back into the community to provide vital support to programs that support youth, education, senior citizens, education, law enforcement, fire service and veterans.

Eliminating this essential revenue source for our dedicated service club organizations and veterans organizations at this critical point as our society emerges from the throes of the pandemic, would definitely hamper our community's ability to fully recover.

Please do not eliminate, or implement any further restrictions to the existing fireworks ordinance, regarding the sale of safe & sane fireworks.
