# Subject: Compliance with SB-205: Identifying industrial facilities that require NPDES Permit coverage through business licensing

Dear Business Operator:

Senate Bill 205 requires the City of Hawthorne to identify industrial facilities that require coverage under the Statewide General NPDES Permit for Stormwater Discharges Associated with Industrial Activities (IGP) through business licensing. The purpose of the IGP is prevent the discharge of industrial pollutants to local waterways. To comply with SB 205, industrial businesses must provide the following information with new business license applications or renewals:

- Primary Standard Industrial Classification (SIC) codes
- The IGP Waste Discharge ID (WDID) number

The Standard Industrial Classification (SIC) code is a national classification database used to track various business types. There are 541 SIC codes that determine a need coverage under the IGP. This includes:

- 1. Manufacturing, production, and transportation (SICs 2011 to 3999)
- 2. Warehousing or transportation facilities with vehicle maintenance (SICs 4011 to 4581)
- 3. Wholesale trade of used auto parts, scrap/waste, or petroleum (SICs 5015, 5093, 5717)
- 4. Landfills, dumps, and waste processing facilities (SIC 4953)
- 5. Electric and sewer service facilities (SIC 4911, 4952)
- 6. Livestock facilities and dairy and equine farms (SICs 0251 to 0259, 0211 to 0214, 241)
- 7. Mining operations (SICs 1011 to 1499)

If your facility's primary SIC code (or codes) fall within the ranges listed above, your business license will not be approved until you provide proof of coverage under the IGP by listing your WDID number. Note that if an industrial facility does not have industrial activities or materials exposed to stormwater, it may qualify for a conditional exclusion from specific IGP requirements by applying for a No Exposure Certification (NEC).

The following page is a short Frequently Asked Questions (FAQ) on determining a facility's SIC code, determining enrollment under the IGP, and enrolling under the IGP and NEC.
