3. CHIEF ISHII DISCUSSION ON THE POLICE OFFICER - PRE-SERVICE/LATERAL RECRUITMENT

Chief Ishii discussed the nationwide shortage of police officer that is affecting the Hawthorne Police Department's ability to recruit. Due to the nationwide demand for qualified candidates, the Police Department interviewed and presented conditional offer of employment letters to candidates ahead of an approved eligible list. Alison Stevens, Assistant City Attorney, confirmed that the Hawthorne Muni Code gives the City Manager authority to make personnel decisions in situations requiring emergency need. Per the City Manager's approval, two (pre-service) police officers started working on with the department on December 18, 2020. Chief Ishii kindly requested the approval of the eligible list and requested that the Commissioners make an exception to policy to approve the retroactive hire date. Ms. Stevens advised the Chief and the Commission to vote on the approval of the eligible list today and vote on the approval of retroactivity during a Special Meeting next week.
